Details of Academic Visit:

- As a part of third year BAMS curriculum an academic visits to Kalol session court were organised on 24/8/22 & 25/8/22 for third year BAMS students to witness the actual proceedings of court.
- Prior permission for visit was obtained from honourable justice P.H Singh (Principal Senior Civil Judge) and students were grouped in six batches and allotted to different courts which were headed by A.A Nanavati Additional District Judge, Ms UB Devda Additional Civil Judge & Mrs M A Kaushik Additional Civil Judge.
- **The purpose of the visit was**
 - ✓ To understand the working of the court, nature of the duties of the judicial officers. The visit was an opportunity for students to understand the role of court in dispensing justice in any case in a live court room.
 - ✓ The role of prosecutors in a case, the way cases proceeded in a court, the way judges prosecutors and defence lawyers handle the case.

The visit gave an opportunity to practically witness the day to day functioning of the court

- Students discussed both criminal cases and civil cases with judges. They were privileged to see medico legal report formats practically which includes Inquest report, summons, post-mortem report .
- The judges imparted informative lecture about current affairs related to criminal and civil cases, torts undergoing in medico legal cases. Knowledge about cybercrimes which are prevailing nowadays, juvenile cases their norms and regulations and matrimonial disputes. At the end of the session students were given a chance to ask their questions and almost all students actively participated.

The trials :-

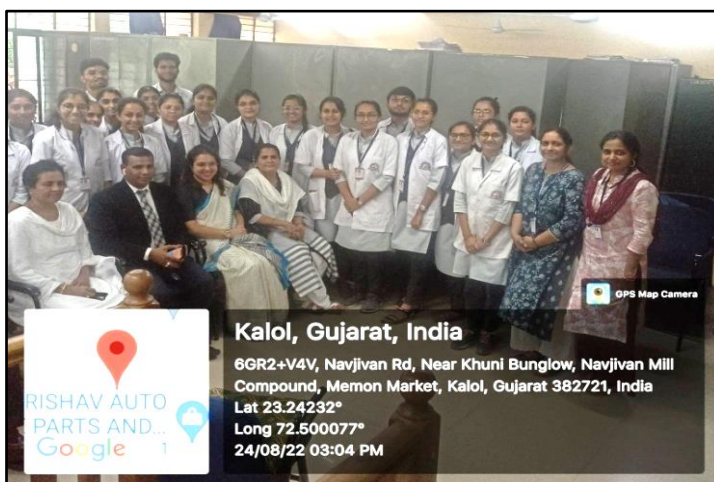
- ✓ Medico legal cases related to alcoholism

In between the trial judges explained them about police investigation, details of injury related to the cases.

Both the day was informative as students were exposed to real courtroom scene and witnessed the proceedings. Now students are more confident in understanding the motions of trials and they feel that this visit helped dispel some of the myths propagated by television and other media about the way trials and arraignment work.
